MEMORANDUM

In pursuance of the G.O.Ms.No.22, dated 27.02.2009 of DP&AR published in the Ex-Ordinary Official Gazette No.15 dated 27.02.2009 of the Government of Puducherry and on the recommendations of the Recruitment Committee the undersigned hereby offers to the full time Casual Laborers mentioned in the **Annexure-I, II & III** to this Memorandum, a temporary post of **Mazdoor** (Group C) in the Department of Agriculture and Farmers Welfare, Puducherry, in the office noted against each in Level-1 of the Pay Matrix. The appointee will also be entitled to draw the Dearness Allowance and other allowances at the rates admissible and subject to the conditions laid down in rules and orders governing the grant of such allowances in force from time to time.


2. The terms of appointment are as follows:-

- i) The appointment is purely on temporary and may be terminated at any time by a month's notice given by either side without assigning any reasons. The Appointing Authority, however, reserves the right of terminating the services of the appointee forthwith or before the expiry of the stipulated period of notice by making payment to him/her a sum equivalent to the pay and allowances for the period of notice or the unexpired portion thereof.
- ii) He/she will be placed on probation for a period of two years from the date of joining in the post.
- iii) Other conditions of service will be governed by the relevant rules and orders in force from time to time.


3. The appointment will be further subject to:-

- i) Production of Certificate of fitness from the Competent Medical Authority (RMO)
- ii) Submission of declaration in the form enclosed (Annexure-IV) and in the event of the candidate having more than one spouse living or being married to a person having more than one spouse living, the appointment will be subject to him/her being exempted from the enforcement of the recruitment in this behalf.
- iii) Submission of attestation form in triplicate for verification of his/her character and antecedents along with the joining report (This Form will be supplied by the Officer to whom he/she reports for duty in the said office)
- iv) He/she will be liable for termination from service in case it is found that he/she was guilty of misconduct involving moral turpitude, which would disqualify him/her to Government service. If it is found that he/she had suppressed any fact for entry into Government service or if any declaration given or information furnished by the candidate proves to be false, he/she shall be liable to be discharged from service and such other action as Government may deem necessary.
- v) The candidate should produce the original certificates of age, educational qualifications and community certificate (obtained from the Competent Authority within 1 year) to the Head of Office concerned for verification and return while joining the post.

4. As no person professing a religion different from Hindu or Sikh religion can be deemed to be a member of Scheduled Caste, the candidate should inform about the change, if any, of his/her religion to their appointing /administrative authority immediately after such a change (This applies only in case of Scheduled Caste candidates).
5. If the candidate accepts the offer on the above terms he/she should report for duty before the Head of Office concerned as mentioned in Annexure-I, II & III immediately and in any case not later than **31.10.2018**. If the candidate fails to report for duty by the prescribed date, the offer will be treated as cancelled and no further request will be entertained.
6. No Travelling Allowance will be allowed for joining the post.



 - i) -- When the Candidate reports for duty he may be appointed as Mazdoor and posted in the existing vacancy. The Head of office concerned is requested to verify the Educational Qualifications, Community certificate and date of birth with the original records. Approval of the Lieutenant Governor has been accorded for relaxing the educational qualification in respect of FTCLRs listed in **Annexure-II** and for relaxing upper age limit and educational qualification in respect of FTCLRs listed in **Annexure -III** for appointment to the post of Mazdoor. Necessary entry in this regard *shall be made in their Service Book*.
 - ii) The Attestation forms in triplicate along with Medical Certificate and the declaration as in **Annexure-IV** may be obtained from the candidate at the time of joining the post and the Attestation Form may be forwarded to the Confirmation Cell, Department of Personnel and Administrative Reforms (Personnel Wing), Puducherry.
 - iii) The date of birth should be verified with relevant documents produced by the individual at the time of report and if found crossed 60 years he/she shall not be allowed to join the post and the offer of appointment should be returned immediately to this department.
 - iv) The Head of Office will be held responsible for deviation in the instructions given above.






