1. At para no. 2,

Earnest Money Deposit @2.5% of the value of amount quoted by the firm in the form of **Demand Draft (DD)** drawn in favour of **The Addl. Director of Agriculture (Horticulture), Botanical Garden, Puducherry**, payable at any **Scheduled Bank, at Puducherry** shall be enclosed along with the tender. Tenders without EMD would be rejected. The EMD will be returned through registered post to the unsuccessful tenders but retained in the case of successful tenderer

Para No. 2. a.

Earnest Money Deposit for Rs. 7,500/- (Rupees Seven thousand five hundred only) in the form of **Demand Draft (DD)** drawn in favour of **The Addl. Director of Agriculture (Horticulture), Botanical Garden, Puducherry**, payable at any **Scheduled Bank, at Puducherry** shall be enclosed along with the tender. Tenders without EMD would be rejected. The EMD will be returned through registered post to the unsuccessful tenders but retained in the case of successful tenderer and will be adjusted against the Security Deposit to be furnished by the successful tenderer.

Para No. 2. b.

The successful tenderer shall deposit an amount of 5% of the tendered and accepted value of the work as performance guarantee as **Demand Draft (DD)** drawn in favour of **The Addl. Director of Agriculture (Horticulture), Botanical Garden, Puducherry**, payable at any **Scheduled Bank, at Puducherry** which shall be refunded after defect liability period (one year) after satisfactory completion of work in accordance with the terms, conditions, specification and items of the work.

Under Terms and Condition at item no.d.

d. The rate quoted should be inclusive of all taxes. If the Government introduces any fresh taxes or increase the present rates of taxes, no change in the rates can be claimed.

d. The rate quoted should be inclusive of all taxes and valid upto one year. If the Government introduces any fresh taxes or increase the present rates of taxes, changes in the rate of taxes shall not be claimed.
