#### **Schedule**

### 2. Terms and Conditions:

- a. The contractor may require to engaging daily an effective strength of labourers for carrying out the work in the supply of manpower for carrying out the quality work.
- b. The Contract labourers are required for a period upto 31.03.2018 and at the maximum of not more than 20 labourers per day.
- c. The Contractor shall engage only physically fit labourers for the works at his sole and own risk.
- d. The contractor will have to execute an undertaking after the award of the work but before the commencement of work.
- e. Quotation submitted shall remain valid up to 31.03.2018
- f. Labourers may be deputed to do some official work outside the campus like shifting of materials, if required. Contractor or his representative should be present daily at all the sites for supervision.
- g. Contractor will be wholly responsible for any loss or damage to the property of Government Horticulture Farm, Madagadipet campus done by him or his employees and all loss, if any will be deducted from contractor dues.
- h. The Contractor must remove all workers deployed by him on termination of the contract or any ground whatsoever from the premises of the Government Horticulture

Farm, Madagadipet and ensure that no person shall create any disruption/hindrance/problem of any nature to the campus.

- i. The quality of the work should be judged at the discretion of the Officer in-charge of the farm and their hierarchical superior is final
- j. The contractor shall have to maintain at his own expense attendance register throughout the contract period in which the daily attendance of the workers shall be recorded.
- k. The Contractor shall be responsible for any loss or damage caused by him or any of his workers by theft or otherwise to the property of the Government Horticulture Farm, Madagadipet and shall pay to Government Horticulture Farm, Madagadipet on demand at the current value of such properties.
