GENERAL INFORMATION TO BIDDERS

1. The Bidders can download the e-Auction documents from the Government e-auction website <https://eauction.gov.in> and also in the Departmental website www.agri.pon@nic.in.
2. The intending bidders before participation in the Online Auction/ bidding process will be required to have individual Digital Signature Certificate (DSC) on its own and to create their user account online by selecting the option of Auction from discipline column and obtain user-id/password on the website <https://eauction.gov.in>. (If already created user account, this step needs to be skipped). For necessary instructions regarding participation in Online Auction please visit the above mentioned website and click on the available link “Information about DSC” at the Home Page for their frequently asked queries (FAQs) regarding Online Bidding Process.
3. Intending bidders will be mandatorily required to sign-up online (create user account) by selecting discipline Auction on the website <https://eauction.gov.in>. to be eligible to participate in the Online Auction. The intended bidder who fails to pay auction schedule fees and EMD under the stipulated time frame shall be restricted to participate under Online Auction.
4. The Bidders shall have to pay auction schedule fees and EMD through offline in two separate Demand Draft (DD) drawn in favour of **“Drawing and Disbursing Officer, office of HG-II, SGWU&SC, Thattanchavady, Puducherry-605 009”** from any Nationalized Bank **payable at Puducherry** and also the scanned copies of auction schedule fees and EMD should be uploaded in the e-auction process through online on or before 20/09/2016 at 4.00 PM
5. The auction schedule fees and EMD should be kept in a sealed cover super scribed as **“Auction Schedule Fees and EMD For The Disposal Of One Condemned LMP-I Rig”** addressed to **“The Hydrogeologist-II, O/o the Hydrogeologist-II, State Ground Water Unit & Soil Conservation, Department of Agriculture, Thattanchavady, Puducherry-605009**. This auction schedule fees and EMD should reach the above said office address on or before **20/09/2016 at 4.00 PM**. The auction schedule fees and EMD received after the due date will not be accepted. **This Department will not be responsible for any of the postal delay.**
6. As the bidders who made payment (**through offline and also uploading scanned copy through online**) can only be able to participate in live e-auctions after the approval of Auction committee. Those approved bidders may participate in the Online Auction by submitting / placing his/her bid(s) in the e-auction website <https://eauction.gov.in> on **21.09.2016 from 10.00 AM upto 04.00 PM**.
7. Bidders are requested to stick on to the date and time specified strictly. Bids will be accepted only if submitted in the prescribed manner. Bidders are requested to read the instructions on the available link “Help for Contractors” at the home page of the website <https://eauction.gov.in> before submission of bids through online.

8. Training regarding the e-auction procedure and submission of bids is also provided in the e-Procurement cell, IIIrd Floor, Chief Secretariat, Puducherry-1. Help desk No.0413-2220225.

9. The brief description of the LMP-I Rig and its accessories can be viewed at **Annexure** of this document.

TERMS AND CONDITIONS OF THE ONLINE AUCTION

1. The online auction for the disposal of one condemned LMP-I Rig bearing Reg.No.PYZ-8548 will **start on 21/09/2016 at 10.00 AM and will conclude (close) on the same day at 04.00 PM.**

2. The LMP-I Rig and its accessories will be sold on “as is where is basis” and “as is what it is basis”.

3. Pondicherry State Sale Tax (VAT), as applicable at the time of rules in force shall be charged extra over and above the Highest Bid accepted.

4. It is the sole responsibility of the bidder to inspect the vehicle and its accessories physically (thoroughly and carefully) in working hours on any of the working days with the permission of Head of Office, before quoting any price for the same.

5. **Bid Incremental Value:-** The minimum bid incremental will be in multiple of Rs.1000/- (One Thousand only).

6. **Bid Submission:**

(a) Any bidder interested to participate in the e-Auction can submit his bid/s through online **from 10:00:00 A.M. to 4:00:00 P.M. on 21.09.2016.**

(b) However, in case any bid in respect of any Vehicle/Item is received 05 minutes prior to time fixed for the closer for the bid i.e. bid received between 3:55:00 P.M. to 3:59:59 P.M. and so on then the time of closer of the entire e-Auction in respect of all the Items/Vehicles would be extended automatically by 5 minutes, so that equal opportunity is made available to the persons participating in the bidding process.

(c) In case, the bidding continue during such extension of 5-5-5 minutes, the bidding process will finally conclude at 04:15:00 P.M. and no further extension would be given thereafter.

(d) The bids offered/received during the e-Auction process shall be provisionally accepted and will be subject to final approval as per the provisions given in Para 10 below.

7. **Decision of e-auction:** The decision of the e-Auction will be as under:-

(a) After the close of Online Auction, the online bids received will be put up before the Disposal Committee for the final acceptance/rejection of the bid.

(b) The above committee reserves the right to accept/reject any bid without assigning any reason thereof.

(c) The proceedings of the Disposal Committee as above shall be approved by the Director, Department of Agriculture, Puducherry.

(d) Acceptance letters for rates shall be sent to the successful bidders to their address along with a copy to Indenting Department.

8. **Deposit of Sale Value of the Vehicle:-** The bidder whose highest bid has been accepted and has been issued acceptance letter will deposit the Sale value of the LMP-I Rig mentioned in the acceptance letter with this Agriculture Department within 7 working days from the date of issue of acceptance letter of their highest quoted rate.

9. **Deposit of Sales Tax (Pondicherry State VAT):-** The bidder whose highest bid has been accepted and has been issued acceptance letter will deposit the VAT (@ % at the time of ruling) of Sale Value of the LMP-I at the time of rules in force in the form of Demand Draft issued in favour of “The DDO, O/o HG-II, SGWU&SC, Department of Agriculture, Puducherry” payable at Puducherry within 7 working days (between 09.00a.m. to 5.00p.m) from the date of issue of acceptance letter in their favour. The sale tax once deposited will not be refunded under any circumstances.

10. **Release Order for Vehicle:-** On receipt of documentary proof of deposit of Sale Value of LMP-I Rig and Deposit of Sales Tax (VAT) as stated in Para 08 and 09 above, the Disposal Committee will issue Vehicle Release Order to the successful bidder.

11. **Place of Delivery:-** The LMP-I Rig will be delivered at the O/o the Hydrogeologist-II, SGWU&SC, Department of Agriculture, Agricultural Complex, Thattanchavady, Puducherry in as is where is condition to the successful bidder after producing the release order to the store section of this same office.

12. **Transfer of Registration No. of LMP-I Rig:-** The Department of Agriculture will allow the successful bidder to transfer the Registration No. of the LMP-I Rig at his / her own cost deposited to the Transport Department of Puducherry.

13. **Refund of Participation Fees (EMD):-**

(a) In case of unsuccessful bidders (whose rates are not Highest), the EMD will be refunded within 2 working days from the date of close of Online Auction through person or through post.

(b) In case of successful bidders whose rates have been accepted and acceptance letter has been issued in this regard, their Participation Fees (EMD) shall be retained till the time of completion of payments process of case as mentioned in Para 08 and 09 above. Once the successful bidder deposits the Sale Value of the LMP-I Rig along with Sales Tax (VAT) as mentioned in the acceptance letter at the designated places and within the specified time period and finally the release order of the vehicle will be issued in their favour, their EMD will be refunded or adjusted against the sale value of the LMP-I Rig.

14. **Forfeiture of Participation Fees (EMD):-**

After issuance of the Acceptance Letter:- The EMD will be forfeited if the bidder fails to deposit the requisite Sale Value of LMP-I Rig along with Sales Tax (VAT) within the stipulated period after issuance of the acceptance letter in his/her favour.

15. The Director of Agriculture, Puducherry reserves the right to accept / reject any bid without assigning any reason thereof.

16. All the cases of dispute, if any, will be settled subject to jurisdiction of Puducherry region.
